

## **Chapter Bylaws Of the Miamisburg Chapter of the National Honor Society.**

Adopted: 5/22/18

### **ARTICLE I: NAME**

The name of this chapter shall be the Miamisburg Chapter of the National Honor Society of Miamisburg High School.

### **ARTICLE II: PURPOSE**

The purpose of this chapter shall be to create an enthusiasm for scholarship, to stimulate a desire to render service, to promote worthy leadership, and to encourage the development of character in students of Miamisburg High School.

### **ARTICLE III: POWERS**

**Section 1.** This chapter operates under the direction of and in full compliance with the NHS National Constitution. See [www.nhs.us/constitutions](http://www.nhs.us/constitutions).

**Section 2.** The chapter adviser(s) is given the authority to supervise the administration of chapter activities, as delegated by the school principal.

**Section 3.** Final authority on all activities and decisions of the chapter resides with the school principal. (See Article V, Section 1 of the National Constitution.)

**Section 4.** Nondiscrimination. Our chapter of NHS maintains policies and practices that are designed to prevent discrimination against any qualified candidate or member on the basis of race, color, religion, ancestry, national origin, gender, and disability. This policy of nondiscrimination applies to all practices, including the chapter administration and the selection, discipline, and dismissal of members.

### **ARTICLE IV: MEMBERSHIP**

**Section 1.** Membership in this chapter is an honor bestowed upon deserving students by the faculty and shall be based on the criteria of scholarship, service, leadership, and character.

**Section 2.** Membership in this chapter shall be known as active, honorary, and alumni. Active members become alumni members at graduation. Honorary members are selected at the discretion of the faculty council. Alumni and honorary members have no voice or vote in chapter affairs.

**Section 3.** Eligibility:

- a. Candidates eligible for selection to this chapter must be members of the junior or senior class.
- b. To be eligible for selection to membership in this chapter, the candidate must have been enrolled for a period equivalent to one semester at MHS.
- c. Candidates eligible for selection to the chapter shall have a minimum cumulative *weighted* grade point average of 3.75 on a 4.0 scale.
- d. Upon meeting the grade level, enrollment, and GPA standards, candidates shall then be considered based on their service, leadership, and character.

## **ARTICLE V: SELECTION OF MEMBERS**

**Section 1.** The selection of members to this chapter shall be by a majority vote of the faculty council, which consists of five faculty members appointed by the principal. The chapter adviser shall be the sixth, non-voting, ex officio member of the faculty council.

**Section 2.** The selection of active members shall be held once a year during the first semester of the school year.

**Section 3.** Prior to the final selection, the following shall occur:

- a. Students' academic records shall be reviewed to determine scholastic eligibility.
- b. All students who are eligible scholastically (i.e., candidates) shall be notified and asked to complete and submit the candidate application, including essay and external recommendation, for further consideration.
- c. The faculty shall be requested to evaluate candidates determined to be scholastically eligible using the official input form provided by the chapter adviser.
- d. The faculty council shall review the candidate information forms, faculty input, and other relevant information to determine those who fully meet the selection criteria for membership.

**Section 4.** Candidates become members when inducted at a special ceremony.

**Section 5.** An active member of the National Honor Society who transfers from this school will be given an official letter indicating the status of his/her membership.

**Section 6.** An active member of the National Honor Society who transfers to this school will be automatically accepted for membership in this chapter. The faculty council shall grant to the transferring member one semester to attain the membership requirements and, thereafter, this member must maintain those requirements for this chapter in order to retain his/her membership.

**Section 7.** Appeals. The decision of the Faculty Council is final.

## **ARTICLE VI: OBLIGATIONS OF MEMBERS**

**Section 1.** Annual dues for this chapter shall be \$20. Dues will be payable to the chapter within 30 days of induction.

**Section 2.** Each member of this chapter who is in good standing with regard to the membership standards and member obligations shall be granted the privilege to wear the emblem adopted by the National Honor Society.

**Section 3.** Any member who withdraws, resigns, or is dismissed from the chapter shall surrender the privilege of wearing the emblem to the chapter.

**Section 4.** Chapter members who are seniors in good standing shall be granted the privilege of wearing the honor cords at graduation.

**Section 5.** Members must turned in completed NHS Member Pledge form within 30 days of induction.

**Section 6.** Members must meet the annual service hour requirement.

**Section 7.** Members must participate in an annual fundraiser as determined by the officers.

**Section 8.** Members must participate in all service projects determined by the officers, not to exceed 3 per school year.

## **ARTICLE VII: OFFICERS**

**Section 1.** The officers of the chapter shall be president, vice president, secretary, treasurer and points secretaries(2).

**Section 2.** Student officers shall be elected at the last meeting of each school year. All members in good standing with the chapter are eligible to run for a position as an officer. Any active member can nominate an eligible member as a candidate for office.

**Section 3.** Voting shall be by secret ballot. A majority vote shall be necessary to elect any officer of this chapter. If the first vote does not yield a majority, a second vote shall be taken of the two candidates receiving the highest number of votes.

**Section 4.** It shall be the duty of the president to preside at the meetings of the chapter, and serve as the official representative of the chapter at school and community functions.

**Section 5.** The vice president shall preside in the absence of the president and shall also keep a record of attendance of members. Vice president will be responsible for notifying members absent from a meeting. Vice president shall also preside at make up meetings held within 1 calendar day of regularly scheduled meetings.

**Section 6.** The secretary shall create membership meeting agendas and keep the minutes of all membership and officers meetings.

**Section 7.** The treasurer shall keep the record of business expenses, dues, and all other financial transactions of the chapter.

**Section 8.** The point secretaries shall be responsible for tracking member service hours and notifying members mid-year in cases where fewer than half of required hours have been submitted.

**Section 9.** Officers and the faculty adviser(s) shall collectively be known as the chapter's executive committee. The executive committee shall establish annual goals for the chapter and have general charge of the meetings and the business of the chapter. Any action by the executive committee is subject to the review of the chapter members.

## **ARTICLE VIII: MEETINGS**

**Section 1.** Regular meetings of this chapter shall be no more frequent than monthly. Special meetings can be called by the president with approval of the adviser.

**Section 2.** This chapter shall conduct its meetings according to *Robert's Rules of Order*.

**Section 3.** Members are expected to attend all chapter meetings. Any member who misses a meeting (and makeup meeting) will be expected to add one additional service hour per meeting missed. Members missing two meetings in a school year may be subject to dismissal.

## **ARTICLE IX: ACTIVITIES**

**Section 1.** The chapter shall determine one or more service projects for each year.

**Section 2.** All members shall regularly participate in these projects.

**Section 3.** These projects shall have the following characteristics: fulfill a need within the school or community, have the support of the administration and the faculty, be appropriate and educationally defensible, and be well planned, organized, and executed.

**Section 4.** Each member shall have the responsibility for choosing and participating in both community and school service activities of their choice. Members must submit documentation of attendance at these activities on the required form. At least half of the required service hours for a membership year must be school activities. This is in addition to the chapter projects to which all members contribute.

**Section 5.** The chapter shall publicize and promote its projects in a positive manner.

## **ARTICLE X: DISCIPLINE and DISMISSAL of MEMBERS**

**Section 1.** Any member who falls below the standards of scholarship, service, leadership, or character may be considered for discipline or dismissal from the Miamisburg chapter of the National Honor Society. A member of the National Honor Society is expected to maintain his/her academic standing and take an active role in service and leadership in his/her school and community.

**Section 2.** If a member's cumulative grade point average falls below the standard in effect when he/she was selected (3.5 for class of 2019, 3.75 for all future classes), he /she will be given a written warning and a reasonable time period for improvement. If the cumulative grade point average remains below standard at the end of the warning period the student will be subject to further disciplinary action by the faculty council that can include consideration of dismissal from the chapter.

**Section 3.** Violations of the law or school regulations can result in immediate consideration of the dismissal of a member (see Section 5 below). These violations include, but are not limited to DWI; stealing; destruction of property; cheating; truancy; or possession, selling, or being under the influence of drugs or alcohol at school or school-related activities or in the community.

**Section 4.** Offenders of the school conduct code (such as use of profanity, failure to comply, unexcused absences, excessive tardiness, etc.) will receive written warning notification. A conference may be requested by either party (faculty council or student/parent). If the member is involved in another violation of the school conduct code, the member may be considered for dismissal.

**Section 5.** Chapter officers, as representatives of the chapter, can be removed from their positions as a consequence of disciplinary action taken by the faculty council.

**Section 6.** In all cases of pending dismissal:

a. The member will receive written notification from the adviser/faculty council indicating the reason for consideration of dismissal.

b. The member will be given the opportunity to respond to the charge(s) against him/her via a written statement presented before the faculty council prior to any vote on dismissal (in accordance with due process identified in Article X of the National Constitution).

A majority vote of the faculty council is needed to dismiss any member. The member will be notified in writing regarding the faculty council's decision.

c. The results of the faculty council vote will be presented to the principal for review, and then stated in a letter sent to the student and parents. Dismissed members must surrender any membership emblems to the adviser.

d. The faculty council's decision may be appealed to the building principal and afterwards according to provisions of the school district discipline policies.

e. A member who is dismissed or resigns may never again be considered for membership in the National Honor Society.

**Section 7.** In lieu of dismissal, the faculty council may impose disciplinary sanctions upon a member as deemed appropriate.

**ARTICLE XI: RATIFICATION, APPROVAL, and REVIEW.**

**Section 1:** These bylaws will be approved upon receiving a two-thirds affirmative vote of all active members of the chapter, a majority affirmative vote of the faculty council, and approval by the administration.

**Section 2:** These bylaws shall be reviewed and if necessary, revised within five years from the date of approval noted on this document.

**ARTICLE XII: AMENDMENTS**

These bylaws may be amended by a two-thirds vote of the chapter, provided notice of the proposed amendment has been given to members at least one month prior to the vote. The exceptions are Articles V and X, which are developed by the faculty council with the approval of the principal (selection and discipline).

(Note: It is recommended that the ratification and amendment articles be the final articles. It is acceptable for the chapter to insert additional articles.)
